
有關會所沖身間收費意向調查結果

結果:



Findings of Questionnaires regarding Setting Up Charges for Showers in Clubhouse

Management Services Office distributed questionnaires regarding the captioned issue to all residents on December 15, 2015 in order to seek for your opinion. As a result, 934 copies of completed questionnaires (57.5% of total no. of accommodation) were collected. The detail results are shown as follow:-

Q1: Do you agree to set up charges for shower in clubhouse?

Findings:

Agree: 820 copies (87.8% of returned copies) (50.5% of total no. of accommodation)


Disagree: 114 copies (12.2% of returned copies) (7% of total no. of accommodation)



Q2: The charge we proposed for shower is HK\$10 per time, do you think if it is appropriate?

We based on the total returned copies of agreement of setting up charges for shower (i.e. 820 copies)

Findings:

Appropriate: 699 copies (85.2% of returned copies of agreement to set up charges)

Inappropriate: 12 copies (1.5% of returned copies of agreement to set up charges)

Other charges recommendation: 109 copies (13.3% of returned copies of agreement to set up charges)
