問題二:你贊成採用以下那個可行方案?


- A. 將現時舊有電腦車咭出入系統更換新電腦車咭系統,時租出入則改用八 達通出入及付費系統。

Findings of Questionnaire regarding the Replacement of Carpark Access System with Octopus Access System


Management Services Office distributed questionnaires regarding the captioned issue to all residents on December 15, 2015 in order to seek for your opinion. As a result, 549 copies of completed questionnaires (60% of total no. of accommodation) were collected. The detail results are shown as follow:-

Q1: Do you agree to replace the carpark access system with Octopus access system?

Findings:

Agree: 464 copies (84.52% of returned copies) (50.71% of total no. of owner Carpark Spaces)

Disagree: 85 copies (15.48% of returned copies) (9.29% of total no. of owner Carpark Spaces)

Q2: Which plan do you support most?

Plan A. Renew the Tag Master System, while the Hourly Rental Access System changes to Octopus Access System.

Plan B. Combine the whole carpark system and replace it with Octopus Access System for access and payment at once.

We based on the total returned copies A agreement of replacement the carpark access system with Octopus System. (i.e. 464 copies):

Findings:

Plan A: 145 copies (31.25% of returned copies of agreement of Q1)

Plan B: 319 copies (68.75% of returned copies of agreement of Q1)
