
Signature Campaign - Strive to Build a Rest Garden
on the "Government, Institution or Community" Site in front of Aegean Coast

We are informed by Ms Chu Shun Nga, Beatrice, Tuen Mun District Councilor (representing our constituency – Hanford) that a resolution of developing a rest garden on the “Government, Institution or Community” site in front of Aegean Coast was passed during the meeting of Tuen Mun District Council held on May 4, 2021.

However, a document signed by some Tuen Mun District councilors submitted to Commerce, Industry and Housing Committee of Tuen Mun District Board, those councilors suggested to build a multi-storey complex building which providing shopping points, public services units, indoor and outdoor recreational facilities, clinics and rest place for the needs of Tuen Mun southeast area residents. It reveals that district councilors from other areas have different ideas for the use of the above site area. Therefore, the ultimate use of the site is still undetermined at this moment.

As the said site is adjacent to our property, if there are new building(s) on the site, it will badly affect the scenic view and air-flow for the flat units on the lower level. We know that our residents always hope the said site to be developed as a rest garden, therefore, we now prepare signature sheets placed on the services counter at each ground floor lobby of tower, we would like to collect your signatures and passed to Ms Beatrice Chu, then she can represent our voice and strive for building a rest garden on the said area. We hope we could collect 70% of the total flat units to support this campaign. Please sign your name to show your opinion on or before May 18, 2021.

要求將愛琴海岸對出「政府、機構及社區」用地
發展作休憩公園簽名運動

業主委員會最近收到本區區議員朱順雅小姐通知，指於 2021 年 5 月 4 日舉行的屯門區議會會議上已通過將愛琴海岸對出的用地發展作休憩公園。

不過，根據較早前一份由部份屯門區議員呈交屯門區議會工商業及房屋委員會第六次會議的討論文件中，有區議員建議將愛琴海岸對出官地興建多層式綜合服務設施大樓，包括購物點、公共服務單位、室內及室外康樂設施、診所、休憩空間等，以服務屯門東南居民。可見屯門不同分區的區議員對有關土地的運用持有不同意見，故有關土地之用途仍存在變數。

由於上述官地貼近本屋苑，若興建多層式大樓將對本屋苑低層單位的景觀及通風造成影響。我們理解居民一直希望爭取興建休憩公園，現希望收集各業戶的簽名，透過本區區議員朱議員將居民的意向反映，祈望有關興建能依本區大部份居民的意向為依歸。


